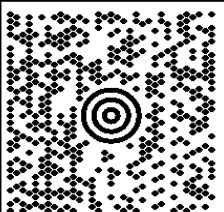
- 1 **Print the label:** Select Print from the File menu in this browser window to print the label below.

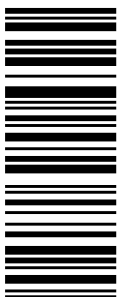

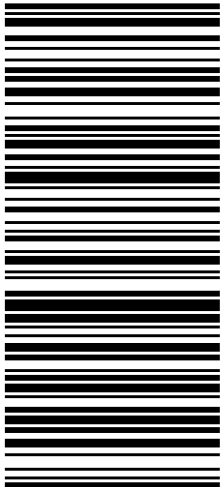
