- 1 **Print the label:** Select Print from the File menu in this browser window to print the label below.
- 2 **Customs Invoice** - 3 copies of a completed customs invoice are required for shipments with a commercial value being shipped to/from non-EU countries. Please insure the customs invoice contains address information, product detail - including value, shipment date and your signature.
- 3 **GETTING YOUR SHIPMENT TO UPS**
- Air shipments (including Worldwide Express and Expedited) can be picked up or dropped off. To schedule a pickup, or to find a drop-off location, select the Pickup or Drop-off icon from the UPS tool bar.

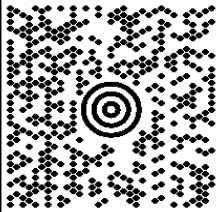

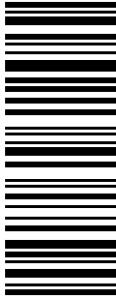

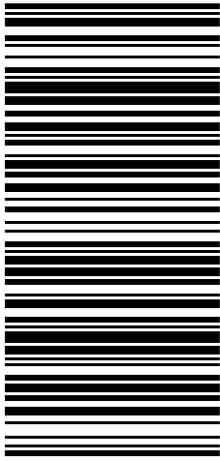
